Dear Resident of Smoketree Stanton:

"All vehicles must display a Smoketree parking hang tag between the hours of 9:00 pm and 7:00 am, or they will be subject to a cite once, then tow policy. This means a vehicle owner will receive one citation and then the vehicle will be subject to tow if parked in the community after that date. (ie: cite on Saturday, tow on Sunday)."

Residents will be allowed to safe list a vehicle for their guest **seven days** out of every 90 days. This will allow an out-of-town visitor to park for a week if needed. Homeowners may not safe list a vehicle not registered to a Smoketree address. **Please see the final section of the parking rules for safe listing procedure.** 

Vehicle owners will be responsible for all cost relating to the cost of the tow and will need to contact California Coastal Patrol to schedule pick-up vehicle. **California Coastal Patrol 714-563-1821** 

## To offset the cost of the parking program, the cost of the permits will be \$40.00 per permit and this cost will renew every year in January.

Attached is a parking permit application along with the newly revised and Board-approved parking enforcement policy. Essentially, qualifying for a permit has not changed. To be permitted for a third (or more) vehicle, each household must have two vehicles parked in the garage and there must also be two or more licensed drivers per household. Counting the vehicles in the garage, the number of vehicles parked on the premises will be limited to one more than the number of licensed drivers in the household. The number of parking permits to park in the common area shall be limited to one less than the number of licensed drivers in the household.

Please read the attached parking policy. If you desire a permit and meet the qualifications, please fill out the application and submit it to the Management Company. Once the application is approved, you will be notified so that you may pay for and pick up the permit. Applications will be processed within 30 days if the paperwork is complete. You may pay by check or cashier's check. Cash and credit cards cannot be accepted.

Please make sure that the application is signed on the next page. Once your application has been approved, you will be notified. You then may pay for and pick up your permit at the Management Company. Applications will be processed within 30 days.
